AGREEMENT

- 1. All students have to keep discipline in the class room and obey the order of Director, Principal, General Manager and Instructors.
- 2. All students have to remit the monthly fees, mess fees on the prescribed date without any fail. Otherwise fine will be charged as per the college rule.
- 3. A minimum of Rs. 500/- (Rupees five hundred only) may be compulsorily deducted from each Caution Deposit (Class room, workshop and hostel) for maintenance and welfare.
- 4. If the Course is not completed within the time, Director of the College have the full right to extend the Course period and students cannot question.
- 5. Remitted amount for the whole Course (Part or full) will not be refundable under any circumstances even a student not able to attend the class.
- 6. Students discontinue the Course have to remit balance monthly fees and collect the documents from College within 20 days.
- 7. All students have to wear prescribed uniform in the class room & practical centre on all working days strictly.
- 8. If any damage occured in the hostel/ college, a fine will be charged as per the rule.
- 9. Order from hostel warden may obeyed by students for the better discipline.
